1. **There is a \$3 Exhibitor Entry fee for the entry of each club an exhibitor enters under. If you make entries from 2 different clubs you will owe \$3 for each club. All entry fees must be paid by the entry deadline to avoid late charges. Note: Cloverbuds do not make individual entries.**
2. All Jr. Fair entries must be made on this form or photo copy of form. Open Class entries must be made on an Open Class Entry form.
3. Entries must be signed by member, parent and club advisor/or teacher if a school project.
4. On **July 11th** all Jr. Fair exhibitors will be mailed verification of their entry. If you do not receive this notice it is your obligation to contact the fair office to confirm entries and mailing address.
5. All entries must be received by or mailed to: The Hartford Fair, 14028 Fairgrounds Rd. NW, Croton, OH 43013-9794. Additional entry blanks can be printed from the website: www.hartfordfair.com
6. Read the general and department rules in the premium book. Correct and accurate entries are your responsibility.
7. Changes must be requested in writing. NO changes will be allowed after Noon on **July 25, 2020**.
8. A \$10 late fee must accompany any entry or entry fee submitted after the entry deadline of **June 27, 2020** and before noon **July 25, 2020**.
9. Premiums will be paid in cash fair week. Livestock sale checks will be mailed 30 days following the fair. \$35 fee will be deducted for re-issued checks.
10. Posted stalling assignments are final. We reserve the right to remove any tack from stalls/pens/cages not being used strictly for the housing of animals.
